AMENDED RULES & REGULATIONS

1. NAME : NAGAR YUWAK SHIKSHAN SANSTHA
2. ADDRESS : Arey Layout, Nagpur-440022 or any other place as decided by General Body from time to time.
3. AREA OF OPERATION : Area of operation of the Society shall be the territory of India in entirety & it may operate outside India.

A) THE DEFINITION OF THE SPECIFIC WORDS IN BYLAWS :

- i) Society : Society means "NAGAR YUWAK SHIKSHAN SANSTHA", NAGPUR.
- ii) President : President means the President of "NAGAR YUWAK SHIKSHAN SANSTHA", NAGPUR.
- iii) Secretary : Secretary means the Secretary of "NAGAR YUWAK SHIKSHAN SANSTHA", NAGPUR.
- iv) Treasurer : Treasurer means the Treasurer of "NAGAR YUWAK SHIKSHAN SANSTHA", NAGPUR.
- v) Managing Committee Members : Managing Committee members means the Managing Committee members of "NAGAR YUWAK SHIKSHAN SANSTHA", NAGPUR.
- vi) Company : Company means any Company as defined in Section 2 of the Companies Act 2013.

4. MEMBERSHIP : There will be 3 categories of members.

a) Life Members:

b) **Ordinary Members :**

Any person who Volunteers to accept the rules of the society and has completed the age of 18 years and is willing to pay the membership fees per annum as below, would be admitted as Ordinary Member on the following conditions -

- i) That he applies for ordinary membership to the Managing Committee and the Managing Committee Approves his Membership.
- ii) And also pays Rs. 1000/- or such higher amount of Membership fees as may be determined by the Managing Committee from time to time. B) CESSATION OF MEMBERSHIP

6. MANAGING COMMITTEE

- i) Any other subject with the permission of the Chairman.
- ii) Special General Body Meeting may be called at any time as decided by the Managing Committee or on requisition of twenty percent of the total members of the society or whenever as deemed necessary by the president.
- iii) Quorum of any general body meeting shall be one third of the total members of the society. No quorum shall be necessary for adjourned general body meeting. If quorum of meeting is not completed, meeting will be adjourned for 30 minutes.
- iv) All the decisions shall be taken by majority of votes, chairman shall have 'Casting Vote' in case of equal voting.
- v) Notice of any general Body meeting shall be given ten days in advance, by circulation or otherwise.
- D) The permanent President shall have a right to preside over the meeting of the General Body and in his absence it shall be presided by any other person, as may be nominated by the president from amongst the member of the Managing Committee. In case, the Life President does not remain present himself or fails to nominate a member to preside over the meeting, the President of such meeting shall be any member, as may be so appointed for the purpose of that meeting according to the majority decision of the members present in the meeting.

- : A) There will be a Managing Committee in whom the powers to manage the affairs and the activities of the society; shall vest. The Managing Committee shall consist of the following 7 Members.
 - a) The President.
 - b) The Secretary.
 - c) The Treasurer.

- d) Two elected members.
e) Two nominated members by the President.

The first Life President shall be Shri. D. R. Meghe.

The Life President shall hold the office till his life and will not be removable from that office by the General Body.

There will be two members called as nominated members of the Managing Committee and the president alone will have a right to nominate these two members of the Managing Committee. The tenure of these two members will be for such period as may be decided by the President. However the President will have a right to terminate these two members of the Managing Committee at any time without assigning any reason. The Secretary, the Treasurer and two members only in the Managing Committee shall be elected according to the majority decision of the General Body for the respective office and the tenure of these office bearers members of the Managing Committee shall be for a period of five years.

The President shall be empowered to appoint any person as deemed fit to be the life president of the society in the event of his death or his resignation. However, in case, the President resigns or dies without having appointed or nominated any person as a Life President, the General Body shall elect a president from amongst itself. B) RIGHTS & DUTIES :

vi) CIRCULATION MEETING :-

Any matter of business of a routine or formal or urgent in nature may be determined by circulation without a meeting of Trustees being held, provided that it is agreed to unanimously by all the Trustees. In case of a difference of opinion such question shall be dealt with at the next meeting of the Trustees.

vi) Filling of vacancies of the Managing Committee :-

If any member resign or dies, the remaining Managing Committee shall fill up the vacancies by passing the necessary Resolution by majority. Any member wishing to resign from the society shall send his resignation in writing to the President.

D) DELIGATION OF POWERS :

The Managing Committee may delegate any of its powers to any of its office bearers or to a committee. At least one office bearer of the Managing Committee must be a members of such Committee and other members may be taken from members of the society or outsiders. The Managing Committee may put any restrictions whole delegating the powers and withdraw the delegation at any time.

7. RIGHTS AND DUTIES OF OFFICE BEARERS OF MANAGING COMMITTEE:

A) LIFE PRESIDENT :

Life President will preside over all the General Body Meetings and Managing Committee Meetings. The President shall have the power to convene meeting of the General Body or of the Managing Committee at any time as he deems fit for transacting and deciding such matters as may be, deemed proper by 24 hours notice by Circulation or otherwise to the members of the General Body or the members of the Managing Committee as the case may be. The President shall be empowered to make, alter, modify, resign, repeal, give effect, restricting effect of, amend or interpret any rules as may be, required for the purposes of proper and effective administration of the society.

It shall be lawful for the President to regulate the work and conduct of the officers, members, employees of the society. The President shall be the custodian of the records and such other property of the society and shall have power to delegate such authority or function to any of the members of the Managing Committee.

The President shall be the final authority to interpret the rules and the articles of the Association and his decision shall be final with respect to the matters not provided in these rules but which are required in order to achieve the aims and objectives of the society. The President shall be empowered to take any action which he deems fit and necessary and also shall be empowered to remove the difficulties in these rules in order to give effect to any action required for achieving the aims and objectives of the society.

Secretary shall have all necessary powers to look after day-to-day working of the society such as issue of notice of meeting, enter into agreement for the purpose as may be approved by the Managing Committee or President, prepare annual report, maintain minutes books of General Body meetings and Meetings of Managing Committees Meetings arrange for safe custody of property and assets, legal matters etc. His powers may be restricted by Managing Committee or Life President, by issuing specific written direction.

Treasurer shall have all power in respect of finance and funds of the society subject to any restrictions as directed by Managing Committee or Life President. Treasurer shall maintain Books of Accounts and get them audited.

They can express their views and vote in Managing Committee Meetings. They may act as members of various Committees.

9 PROPERTY:

- B) Bank account in the name of the society or its institutions shall be opened and operated as decided by the Managing Committee.
- C) Income source of the society shall be membership fees, donations, subscriptions, fees, Government grants, funds, surplus from any activities etc.

D) Provision For Loans And Deposits :-

The Trust can raise loan or deposit from any person or organisations or banks or from financial institutions with the prior sanction of the Joint Charity Commissioner as per the provisions of Bombay Public Trust Act as well can sell or dispose of Trust property subject to prior permission of Charity Commissioner.

All the property Movable and Immovable belonging to the society shall vest in the Managing Committee and will be in the name of the society.

10. DEEDS AND DOCUMENTS:

All Deed and Documents on behalf of the society shall be executed by such members of the Managing Committee as may be authorised by the Managing Committee by a resolution.

11. PROVISION FOR SALE AND PURCHASE OF IMMOVABLE PROPERTY:

The Society can sale or purchase any property, for sale of the immovable property prior permission of the Joint Charity Commissioner, Nagpur will be necessary.

12. PROCEDURE FOR KEEPING THE MEMBERSHIP REGISTER:

According to Section 15 of the Societies Registration Act, 1860, the list of member shall be kept in accordance with Schedule V.I. Rule 15 of the Societies Registration (Maharashtra) Rules 1971.

13. PROVISION FOR CHANGE IN THE NAME AND OBJECTS OF THE SOCIETY:

To change in name and object of the Society or its amalgamation shall be done in accordance with the Section 12 and 12 [A] of the Societies Registration Act, 1860.

14. DISSOLUTION:

The Society shall be dissolved by the 3/5th of the majority in the General body meeting as per the provisions of the Section 13 and 14 of the Societies Registration Act 1860. All property of Society can be donated to the other Society having same objects. Before the dissolution, the accounts of Debit & credit of Society will be completed.




